## ABOUT REPATRIATION 2022

Information for refugees, immigrants and persons with dual citizenship about voluntary return

## ARE YOU THINKING ABOUT RETURNING TO YOUR HOME COUNTRY?

DRC Danish Refugee Council offers counselling about voluntary return according to the Danish act on repatriation. Refugees, immigrants and persons with dual citizenship (Danish citizenship and a citizenship from outside EU) are eligible to receive economic support if they return voluntarily to their home country or to a country in which a parent, children or a spouse resides. The economic support depends on the type of residence permit you have and on when you came to Denmark.

## REPATRIATION BENEFITS

In 2022 adults receive a cash amount of maximum DKK 146.639 to start a new life in your home country. Minors receive up to DKK 44.723.

The cash amount is paid in two instalments; first instalment before departure from Denmark (maximum DKK 58.655 per adults, maximum DKK 17.889 per minor) and second instalment (maximum DKK 87.984 per adult, maximum DKK 26.834 per minor) after one year in the home country.

## OTHER BENEFITS

- Travel expenses,
- Freight costs or cash amount to buy new furniture and personal effects,
- Business equipment and freight costs,
- Health insurance/cash amount for medical costs for 4 years,
- Prescribed medicine for a 1-year period,
- Needed personal medical devices/vaccinations
- Expenditure for schooling for 4 years for children between 5 and 16 of age,
- Expenses related to the acquisition of passport/travel document.

Are you above 55 years of age you may be granted a monthly reintegration allowance from Denmark.

Under special circumstances you may be eligible for the monthly reintegration allowance if you are between the age of 50 and 54.

Normally the reintegration allowance is from DKK 2800 to DKK 3600 every month. In order to receive reintegration allowance you must have had a residence permit in Denmark for minimum 5 years.

In case there is a bilateral agreement of social security between Denmark and your home country you might be able to receive part of your pension.

## THE RIGHT TO RETURN TO DENMARK

**Refugees** are rightfully able to return to Denmark within a year after returning to their home country. This means that refugees may re-obtain their rights and residence permit in Denmark. Making use of the right to return to Denmark involves paying back the full amount of the received repatriation benefits.

**Immigrants** are not able to return or to re-obtain their rights in Denmark after returning to their home country. For immigrants, the decision of returning to the home country is final which entails giving up all rights related to the residence in Denmark.

**Dual citizenship** persons with dual citizenship will be conditionally released from the Danish citizenship before leaving Denmark. Dual citizens can regret the decision of being released from the Danish citizenship for up to two years. If a dual citizen decides to maintain the Danish citizenship the full amount of the received repatriation benefits will have to be paid back.
